- (1) The successful bidder shall begin furnishing bid materials on October 1, 2022 after receiving notice to proceed and continue furnishing said materials until September 30, 2023. The City of Guntersville reserves the right to negotiate with another bidder for the bid items if the low bidder cannot supply the materials within two (2) weeks from the placement of order. At the end of the 1 year term, if both parties agree, this contract could be extended.
- (2) Delivery must be guaranteed a maximum of two weeks from date of order.
- (3) Specific colors used will be the following; cardinal and white. Screen print will need to be either white or cardinal depending on the color of the uniform. These colors coincide with Guntersville High School athletics colors.
- (4) No substitutions without prior Recreation Department approval of material. Substituted material should be of greater quality than original.
- (5) It shall be the bidder's responsibility to possess all Proper City, County, State, and Federal license and shall familiarize himself with and shall comply with all Federal, State, and local laws, ordinances, and regulations.
- (6) The City of Guntersville reserves the right to award this contract as a whole or in part, whichever is in the best interest of the City of Guntersville.
- (7) Bids may be submitted either by mail or in person; however, the City of Guntersville will not be responsible for the security of mailed bids. If mailing bid, please be advised that we do not receive mail before 2:00 P.M. daily, therefore mail early to ensure prompt arrival.
- (8) By the signing and submitting of this bid, the vendor certifies that he/she is an equal opportunity employer.
- (9) Bidders are required to use this "Invitation for Bids" paperwork. Failure to do so will be cause for rejection of bid.
