

**THE MINUTES OF A REGULAR MEETING  
OF THE MAYOR AND CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA  
HELD ON JULY 1<sup>st</sup> 2022**

The Mayor and City Council of the City of Guntersville, Alabama met in a pre-meeting in City Hall in said city on July 1<sup>st</sup> 2022 at 11:30 a.m. to discuss matters to come before the Council. In a regular meeting in Town Hall at 12:00 a.m. Mayor Leigh Dollar presided as Chairman of the meeting. The following members of the Council were present: Sanchez Watkins, Larry Wilson, John Myers, Carson Ray, Dink Myers, Rich Russell and Randy Whitaker. Shelly Thomas acted as City Clerk for the meeting. The Pledge of Allegiance was led by Councilman Randy Whitaker. Mayor Dollar welcomed visitors and declared that a quorum was present and opened the meeting for business.

**Minutes**

Mayor Dollar announced that copies of the minutes from the June 20<sup>th</sup> Regular Meeting have been distributed to the members of the Council. There being no corrections or additions the same on motion duly made and second stood approved.

**Personnel Report** – Mayor Dollar called on Renea Rowan to give the following Personnel Report:

Mrs. Rowan stated there were no new hires to report but that Charlie Boulding was retiring from the City after 19 years.

**Resolution to Surplus Radios for Police Dept**

Mayor Dollar introduced **Resolution No. 1259** to surplus the following for the Police Department that have recently been replaced with the new P25 units:

Portable Radios:

33 - XPR 3500e with chargers and 26 shoulder mics and 3 - PR 860 with chargers and 1 shoulder mic

Mobile Radios:

16 - XPR 5550

13 - XPR 5550e

11 - XPR 4550

2 - XPR 4550 Split Unit

1 - CDM 1550-LS

1 - CM 1250

Motion to approve was made by Councilman Whitaker and seconded by Councilman John Myers and passed unanimously by a voice vote of all Councilmembers present.

**Public Transportation 5311 Resolution Authorizing Local Matching Funds**

Mayor Dollar introduced **Resolution No. 1260** to make additions to the previous Resolution No. 1252 for Public Transportation 5311 Grant (yearly grant). The addition includes the contract amount plus the amount for the bus which totals \$114,049.00. Motion to approve was made by Councilman Ray and seconded by Councilman Russell and passed unanimously by a voice vote of all Councilmember present.

**Public Transportation Resolution Adopting a Title VI Program**

Mayor Dollar introduced **Resolution No. 1261** agreeing that the City's Public Transportation Department will abide by Title VI of the Civil Rights Act of 1964 because our Public Transportation Department receives Federal financial assistance from the Alabama Department of Transportation in support of transit services which imposes certain obligations upon the recipient, including complying with those Title VI Federal requirements. Motion to approve was made by Councilman Wilson and seconded by Councilman Watkins and passed unanimously by a voice vote of all Councilmembers present.

**Public Transportation Resolution for 3 Year Pass Thru Agreement**

Mayor Dollar introduced **Resolution No. 1262** entering into an agreement with the State of Alabama: acting by and through the Alabama Department of Transportation relating to public transportation with partial funding by the Federal Transit Administration, for the City's Public Transportation Department. Motion to approve was made by Councilman Watkins and seconded by Councilman Wilson and passed unanimously by a voice vote of all Councilmembers present.

**Senior Center Resolution for 3 Year Pass Thru Agreement**

Mayor Dollar introduced **Resolution No. 1263** entering into an agreement with the State of Alabama: acting by and through the Alabama Department of Transportation relating to public transportation with partial funding by the Federal Transit Administration, for the City's Senior Center. Motion to approve was made by Councilman Russell and seconded by Councilman Ray and passed unanimously by a voice vote of all Councilmembers present.

**Public Hearing for a Rezoning Request by Zack Farris**

Mayor Dollar stated that the following Public Hearing for a Rezoning Request by Zack Farris to Rezone Property Located at 2195 Taylor Street from RS-2 to Multi Family had been carried over from the last meeting. Jimmy Hanson received a message from Mr. Farris asking to postpone the hearing until the July 18<sup>th</sup> meeting. Councilman Whitaker stated that he spoke with Mr. Farris and that the homes he was building was not going to be for rent but for sale. He also stated that the main entrance/exit would be on Taylor Street. Motion to postpone the public hearing was made by Councilman Whitaker and seconded by Councilman Dink Myers and passed unanimously by a voice vote of all Councilmembers present.
