# THE MINUTES OF A REGULAR MEETING OF THE MAYOR AND CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA HELD ON JUNE $26^{\rm th}~2023$

The Mayor and City Council of the City of Guntersville, Alabama met in a pre-meeting in City Hall in said city on June 26<sup>th</sup> 2023 at 4:30 p.m. to discuss matters to come before the Council. Afterwards in a regular meeting in Town Hall at 5:00 p.m. Mayor Dollar presided as Chairman. The following members of the Council were present: Sanchez Watkins, Larry Wilson, John Myers, Carson Ray, Dink Myers, Rich Russell and Randy Whitaker. Betty Jones acted as City Clerk for the meeting. The Pledge of Allegiance was led by Councilman Randy Whitaker. Mayor Dollar welcomed visitors and declared that a quorum was present and opened the meeting for business.

#### Minutes

Mayor Dollar announced that copies of the minutes from the June 12<sup>th</sup> Regular Meeting have been distributed to the members of the Council. There being no corrections or additions the same on motion duly made and second stood approved.

### Public Hearing for Clase Azul Night Club & Bar LLC

Mayor Dollar announced that this portion of the meeting would be a Public Hearing for Clase Azul Night Club & Bar LLC DBA Clase Azul Night Club & Bar located at 12361 US Hwy 431, Guntersville, Al 35976 for a Lounge Liquor License. Mayor Dollar asked for opposition and there was none. Mayor Dollar asked for support and the owner Jennifer Tovar and Jose Cepeda spoke. Councilman Whitaker went over a list of items that the previous owner had done concerning the bar as far as taxes, fights, gambling and other violations and they stated they understood not to make the same mistakes. They explained that Mr. Cepeda had applied for citizenship when he was 12 and was still waiting for the paperwork, so Ms. Tovar had applied since she was a citizen. Mr. Cepeda stated he wished to hire off duty police and Mayor Dollar explained that the police were already stretched so thin, they may have to hire a security firm. Councilman Wilson asked if they had experience running a lounge and they said they did not, but Mr. Cepeda stated he had a trucking company and automotive business and was familiar with paying taxes monthly and quarterly.
