## Regular Meeting of the Mayor and City Council of the City of Guntersville, Alabama Tuesday, September 15<sup>th</sup> 2025 at 5:00 p.m.

The Mayor and City Council of the City of Guntersville, Alabama met in a pre-meeting in City Hall in said city on September 15<sup>th</sup> 2025 at 4:30 p.m. to discuss matters to come before the Council. Afterwards in a regular meeting in Town Hall at 5:00 p.m. Mayor Dollar presided as Chairman. The following members of the Council were present: Sanchez Watkins, Larry Wilson, John Myers, Carson Ray, Dink Myers, Rich Russell and Randy Whitaker. Betty Jones acted as City Clerk for the meeting. The Pledge of Allegiance was led by Councilman Rich Russell. Mayor Dollar welcomed visitors and declared that a quorum was present and opened the meeting for business.

Mayor Dollar announced that copies of the minutes from the September 2<sup>nd</sup> Regular Meeting have been distributed to the members of the Council. There being no corrections or additions to the minutes, there was a motion to approve made by Councilman Dink Myers, seconded by Councilman Whitaker and passed by a voice vote of all Councilmembers present.

**Personnel Report:** Mayor Dollar called on Renea Rowan to give the personnel report:

**Street/Maintenance:** Charlie Minor has selected Eric Butler to fill the open position of Skilled Laborer. Mr. Butler accepted our job offer and he began his full-time employment today, September 15<sup>th</sup>.

**Sanitation:** Jamie Bishop, Refuse Manager, selected Brock Keller and Logan Johnston to fill the positions of Laborer. Both accepted our job offer and began their full-time employment today, September 15<sup>th</sup>.

There was a motion to approve made by Councilman Whitaker, seconded by Councilman Dink Myers and passed by a voice vote of all Councilmembers present.

### **Special Event License for Alabama Beer Promotions**

Mayor Dollar entertained a motion to consider a special event license for QSC Promotions LLC DBA Alabama Beer Promotions for the Lake City Fall Fest at Errol Allen Park Located at 398 Gunter Avenue, Guntersville, AL on October 10<sup>th</sup> and 11<sup>th</sup> 2025. #### **Charter Franchise Agreement**

Mayor Dollar called on Will Edwards with Charter and Attorney Jim Beard to discuss the Charter franchise agreement. They reported that this was very similar to the past agreement. The main difference is that the time frame is 3 years with a 5 year automatic renewal vs the last one that was 10 years with a 5 year automatic renewal. Mr. Edwards was questioned about response time and outages by Councilman Whitaker and was asked to send Charter Policies to City Hall with the repair number. Councilman Wilson stated that the green hub in his neighborhood had the cable exposed for 14 years and gave Mr. Edwards the address. Councilman Russell asked for data showing how Guntersville was served and Mr. Edwards said he would research. Councilman Dink Myers stated that the Guntersville area was supposed to be served, but he was aware of two houses in the middle of Guntersville without service available. Mr. Edwards said it was because of the terrain.

Councilman Dink Myers made a motion to carry over the approval until the next meeting. Councilman Russell seconded and it passed on a voice vote of all Councilmembers present.

#### **Appoint Alternate Poll Worker**

Mayor Dollar introduced **Resolution No. 1462** to appoint an alternate poll worker. Anna Frederick is trained and was nominated to take the place of Janice Spradlin who will be unable to serve this election. There was a motion to approve made by Councilman Russell, seconded by Councilman John Myers and passed by a voice vote of all Councilmembers present.
